To enable your child to develop their relationship with their key worker and to settle into the nursery routine, we ask for bookings of at least 2 sessions per week.

We also oler flexible, drop-in sessions on Mondays and Fridays which can be booked on a week-to-week basis.

We aim to be as flexible as possible to fit in with your family's childcare requirements but spaces are always subject to availability.

Fees are subject to review by Canopy, and we may amend them by providing you with one months' notice. If the fees are due to change because of your child's age, the new fee rate will apply from the first of the month following that change.

# T&C

#### Useful details

We are open 51 weeks per year and are closed for bank holidays and for one week between Christmas and New Year. Fees are not charged for the week that we are closed between Christmas and New year but <u>fees are still payable for bank holidays</u>. Fees include all meals and snacks but exclude formula milk, nappies, and any highly specific dietary requirements. Fees are payable in advance on the 1st of every month. Unfortunately, there can be <u>no refunds or substitutions for sickness or holidays</u>. Failure to receive payment within 3 days of the invoice due date will result in an administration charge of £125, and your child cannot attend nursery until payment is completed.

#### Discounts

If you have 2 or more children in the nursery at the same time, we oler a sibling discount of 5%. If they attend dilerent sessions then we apply the discount to the child/children with the lower fees.

# **Funding**

We accept Government funding for eligible children from the term following their government funding age which covers 15 or 30 hours of childcare for 38 weeks of the year. Session times for these funded hours are:

#### Just15hrs:

 1 day of 10 hours (8.30am-6.30pm) and 1 day of 5 hours (1.30pm-6.30pm) - days offered will be subject to availability and can also change from term to term.

### Just30hrs:

 2 days of 10 hours (8.30am-6.30pm) and 2 days of 5 hours (1.30pm-6.30pm) - days offered will be subject to availability and can also change from term to term.

#### Stretched Funding:

- For 11 hrs 15 mins:
  - 1 day of 5 hours (1.30pm-6.30pm) and 1 day of 6 hrs 15 mins (8.30am-2.45pm) - days offered will be subject to availability and can also change from term to term.
- For 22 hrs 30 mins
  - 2 days of 10 hours (8.30am-6.30pm) and 1 day of 2 hrs 30 mins (4pm-6.30pm)

For funded hours plus additional hours maximum of 6 hours per day using funded sessions 9am-12 noon and 3.30pm-6.30pm/3pm-6pm:

- Only 1 funded session per AM and PM session can be used.
- Funded sessions can be changed by the nursery with notice to the parents.
- Canopy Wembley Park will confirm the available sessions upon receipt of application.
- Limited funded only places and will be given in priority order of:
  - 1. Existing parent wanting additional sessions
  - 2. First come, first serve with all the paperwork completed including funding code

Funded only sessions cannot be changed unless prior agreement and any changes will require one month notice. Consumable charges applicable for any funded session as detailed in enrolment pack. Additional hours not covered by the funding can be booked at a rate of £12 per hour.

# Registration Fee

A registration fee of £150 (non-refundable) is payable upon securing a place at Canopy Wembley Park for any hours booked which are not funded. No registration fee is charged for a fully funded place.

# Refundable Deposit

A deposit of £300 is required to secure your child's place at Canopy Wembley Park. This will be returned to you in the form of a deduction from your final month's invoice. One week's deposit is required for a fully funded place which will be refunded a month after your child has started

# Waiting list

In the event of us not having a suitable space for your child, we have a strict but fair waiting list process where we will keep you informed of your position in the waiting list and of any spaces as they become available.

#### Place Offer

We ask you to respond as quickly as possible to an oler of a nursery place for your child. If we have not heard from you after 72 hours then we will assume that you are no longer interested and we will oler the place to the next family on the waiting list.

# Right of withdrawal

If you have accepted a nursery place, you have a legal right to change your mind within 14 days. If your child has already started nursery within this time frame then you must pay for the services that you have received.

#### Cancellation

We ask you to provide us with one month's notice in writing of your intention to cancel your child's place

#### Late collection

If your child is collected later than their scheduled collection time, a late collection fee of £15 will be charged for the initial 10 minutes and a further £12 for every 10 minutes thereafter.

# Flexibility

Whilst we try to be as flexible as possible to fit in with your family's plans and commitments, we do require notice of any permanent changes to your routine (I month) and any other requests such as an emergency session swap or an additional ad-hoc session are subject to availability.
